

Verification of 10-Hour Pre-Admission School Field Experience

10-Hour Pre-Admission School Field Experience Required

Applicants to the Teacher Education Program are required to complete a 10-hour school field experience prior to consideration of their application. The experience should be completed with students of the grade level and subject area you intend to pursue (K-6 for Elementary Education, K-12 for Art Education and Music Education, or 5-12 for all other secondary education programs). The experience must be completed in a state-approved school under the supervision of a licensed teacher. Virtual experiences will qualify so long as they involve a real school classroom with a real teacher. Online simulations do NOT qualify. Please use this form to document where, when and with whom the experience was completed. International applicants are encouraged to complete this experience in a school with a U.S. curriculum. Identify a district and call them to ask how to go about volunteering. Most districts will treat this as a volunteer experience. Please follow the school district's instructions for registering as a volunteer. Some districts may require a criminal background check or have other procedures for approval.
