**10-Hour Pre-Admission School Field Experience Required**

Applicants to the Teacher Education Program are required to complete a 10-hour K-12 school field experience prior to consideration of their application. This experience should be: a) in a classroom setting in the grade range and subject area of the program to which you are applying (K-6 or 5-12); b) in a state-approved school and under the supervision of a licensed teacher; and c) during regular in-session hours of the school's standard school year. This field experience must be completed following high-school graduation. Please use this form to document where, when and with whom the experience was completed. International applicants are encouraged to complete this experience in a school with a U.S. curriculum. Most districts will treat this as a volunteer experience. Identify a district and call them to ask how to go about volunteering. Some districts may require a criminal background check or have other procedures for approval.
